During his introductory speech he set the purpose of the meeting and expressed his gratitude towards UGC for selecting the college under the Paramarsh Scheme.

Latter with the permission of the Hon. Chair, IQAC Coordinator Dr. V. S. Kale commenced the proceedings of the meeting by announcing the first item in the agenda.

Item No. 1 in the Agenda.
